

Owner Release and Initial Doggie Day Care Form

Please initial the line after each paragraph.

I understand that Mountain Ridge Animal Hospital cannot guarantee the health of my pet. I understand and will not hold the hospital responsible for conditions that are unavoidable such as, but not limited to; weight loss, hair loss, upper respiratory infections, bronchitis, diarrhea, fleas, dog fights, or wounds occurring during the duration of my pet's stay. I understand all pets admitted to the day care must be protected against communicable contagious diseases and must be free of internal and external parasites or will be treated upon entry or discovery at the owner's or agent's expense. If vaccinations were performed elsewhere I have provided written documentation of all required vaccines. _____

I permit my pet to comingle with other pets for play time. I understand that not all pets get along 100% of the time but that they will be supervised and separated as needed. I also permit my pet to be put in a kennel during cleaning, nap times, or for other reasons. _____

The clinic is to use all responsible precaution against injury, escape or the death of my pet. I understand that in the event of my pet's illness, injury or emergency, the staff will immediately take my pet upstairs to Mountain Ridge Animal Hospital for treatment. I authorize the medical staff to sedate and /or perform such emergency procedures as may be necessary services rendered for and to my pet. I will assume financial responsibility for my pet while at Doggy Day Care. In the event of death of the pet MRANH is authorized to have the body stored until other arrangements can be made. _____

I understand the clinic is not responsible for lost or damaged personal items left with the pet including but not limited to leashes, collars, toys and bedding. _____

I understand that pick up time is no later than 6:30 p.m. unless prior arrangements have been made. In the event my pet needs to stay overnight I will inform MRANH of this as soon as possible. I understand that boarding charges will be added for each night my dog stays and contingent on the needs of my pet. If I neglect to pick up my pet within five days of the date scheduled for discharge and do not notify Mountain Ridge Animal Hospital within that time period, my pet is considered abandoned and MRANH is authorized to dispose of my pet as deemed appropriate by MRANH management. _____

During my pet's stay at MRANH Doggy Day Care my pet will be taken outside on a slip lead style leash and walked in an enclosed area to go to the bathroom. _____

While in Doggy Day care I will allow my pet's picture to be taken by staff for such purposes as MRANH website, to use on social media, or promotional materials. MRANH agrees not to sell or distribute these photos to any third party. _____

I have been provided with a copy of this Doggy Daycare policy handout if requested. _____

I understand that there is an additional charge for any pet deemed aggressive during the boarding or day care period. Management reserves the right to ask that aggressive dogs not return to Doggy Day care. _____
